

Amitabh Bachchan and Manoj Pahwa partner with GSK for new shingles awareness

[v] High blood sugar levels can weaken the immune system, [vi] and when that happens it can increase the risk of reactivation of the chickenpox virus and emergence of shingles. [vii] Vigyeta Agrawal, Patient Empowerment Head, GSK said, "The 2023 API-Ipsos survey showed that even those who had shingles did not know the cause of

this painful disease. [viii] It is essential that all people above the age of 50 years know about shingles and its prevention. We wanted to explain the science behind the cause of shingles and the link between chickenpox and shingles in a simple manner. Amitabh Bachchan has an unparalleled ability to connect with people across all demographics. We are confident that having him as the face of the campaign, will help us reach and encourage more people, especially ageing adults, to talk to their doctor about shingles and its prevention."
